Office Order

University Examination norms provide that students who fail to obtain minimum 50%, 60% & 60% credits offered at the end of first, second and third year respectively of the total credit offered shall be debarred from promotion to second, third and fourth year respectively. Accordingly office orders were issued by the Registrar to debar such students who failed to meet the minimum condition for promotion. Many students have submitted application for relaxation of the conditions on compassionate grounds and promised that they will not repeat such mistake in future. Parents of some students have also personally met the University authorities and requested for a mercy chance.

Keeping in view the interest of students and their parents, it is decided to give conditional promotion to all such students, who have been debarred from promotion, as one time relaxation on compassionate ground as per following terms and conditions:

1. First year students, who have failed to meet the minimum criteria for promotion to Second year shall be allowed to attend Third semester classes and will be required to have minimum 75% attendance in each subject and obtain minimum 55% of the total credits offered till Third semester.
2. Second year students, who have failed to meet the minimum criteria for promotion to Third year shall be allowed to attend Fifth semester classes and will be required to have minimum 75% attendance in each subject and obtain minimum 60% of the total credits offered till Fifth semester.
3. Third year students, who have failed to meet the minimum criteria for promotion to Fourth year shall be allowed to attend Seventh semester classes and will be required to have minimum 75% attendance in each subject and obtain minimum 60% of the total credits offered till Seventh semester.
4. Permission for attending classes in Third/ Fifth/ Seventh Semester shall be granted only when a parent of the students submits an affidavit on non judicial stamp paper of Rs. 10 and duly attested by the First Class Magistrate to the Registrar of the University stating that he/she undertakes to monitor the progress of his/her son/daughter in the current semester and ensure meeting the criteria for promotion as mentioned at serial no. 1 to 3 above by his/her son/daughter. In case his/her son/daughter fails to meet this criteria, neither the student nor parents shall claim any other laxity/relaxation in rules.
5. No student shall be allowed to attend classes Third/Fifth/Seventh semester until and unless he/she has cleared all dues in terms of academic, hostel, transport fees and fine if any.
6. All such students and their parents who want to avail this relaxation must submit the requisite affidavit on or before **September 20, 2016** after which no such relaxation shall be permitted.
7. Registrar Office shall issue a written permission letter addressed to Dean of the School concern with copy to the relevant Officer of the University and attendance of the students shall be counted with effect from the next day.
8. All such students who are permitted to attend classes under this relaxation shall be given opportunity for two in Sem Exams.
