Item No.1 - Confirmation of minutes of previous meeting held on 28.11.2016.

The Minutes of the previous meeting held on 28.11.2016 were read and confirmed.

Item No.2 - To review and evaluate the examination system in the University and assess the results.

The Board discussed about the way of conducting the examinations in the University and evaluated the results so far. In the Academic Year 2013-14 total 1227 students had appeared for the examination, out of which 1151 students were passed, which shows 93.81% result. In 2014-15 total 2021 students had appeared for the examination, out of which, 1905 students were passed. 94.26% students had been passed in 2014-15. In the Academic Year 2015-16 total appeared candidates were 2293, out of which 2156 candidates were passed, which shows 94.03% result.

The Board was satisfied with the overall result of the students, but insisted to increase the result by further improving the standard of teaching.



Item No.3 - To delegate power of the Chairperson to the President for creation and abolition of posts.

The powers conferred upon the Chairperson U/S 39 of the Statute were reviewed and it was decided unanimously to delegate the powers to the President to create and abolish the posts as per the requirement of the University.
